

**BEING A BYLAW OF THE TOWN OF PROVOST TO AMEND BYLAW NO. 07/2010,  
BEING THE TOWN OF PROVOST LAND USE BYLAW.**

**WHEREAS** the Council of the Town of Provost deems it desirable to amend Bylaw 07/2010, being the Land Use Bylaw by re-designating land in the Industrial (M) District to the Highway Commercial (C3) District.

**NOW THEREFORE, under the authority and subject to the provisions of the Municipal Government Act, S.A. 2000, Chapter M-26.1, and amendments thereto, and by virtue of all other powers it enabling, the Council of the Town of Provost enacts as follows:**

1. THAT By-law No. 07/2010, being the Town of Provost Land Use By-law be, and is hereby amended.
2. THAT Schedule "A", Land Use District Map of Land Use By-law No. 07/2010 be amended as follows:
  - a) THAT the Land Use Designation of Lots 7, 8, 9, 10, 11, Block 4, Plan 082, 6443, Lots 7, 8, 9, Block 6, Plan 082 6443 and Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, Block 7, Plan 082 6443, as per attached map Marked Addendum "A", be changed from the Industrial (M) to Highway Commercial (C3) District.
3. THAT this By-law shall come into force and effect upon third reading and final passage in Council.




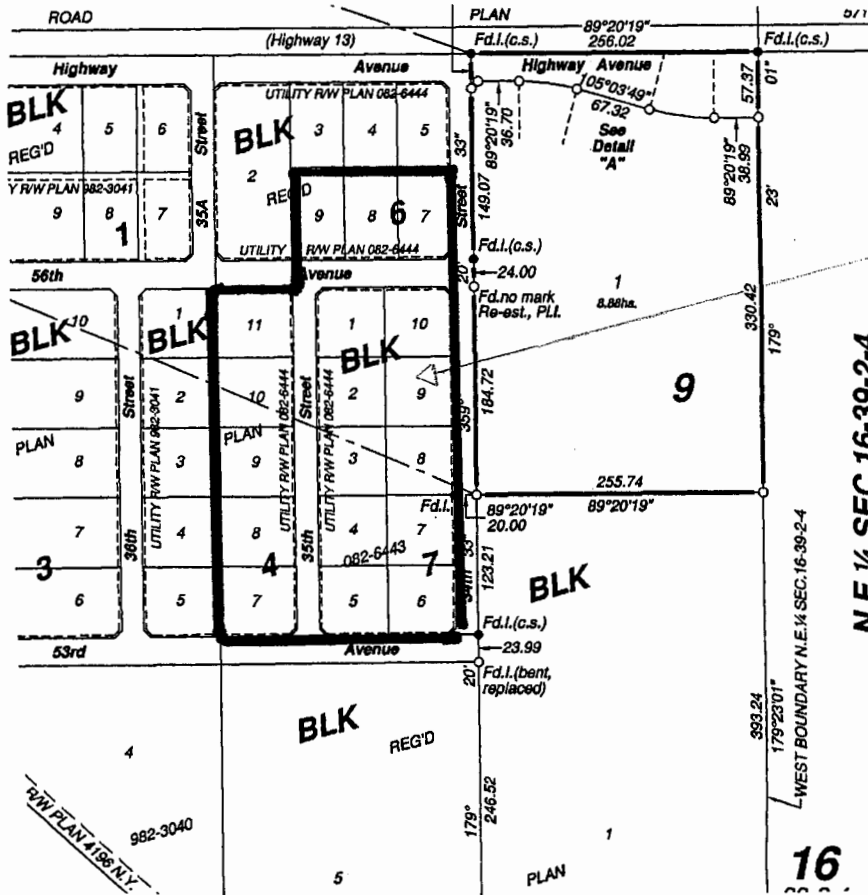

The purpose of Bylaw No. 01/2011 is to amend existing Town of Provost Land Use Bylaw No. 07/2010, to authorize amending the designation of Lots 7, 8, 9, 10, 11, Block 4, Plan 082 6443, Lots 7, 8, 9, Block 6, Plan 082 6443 and Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, Block 7, Plan 082 6443 from the Industrial (M) District to the Highway Commercial (C3) District – as shown on map as follows:
