
**BEING A BYLAW OF THE COUNCIL OF THE TOWN OF PROVOST TO AMEND
BYLAW NO. 07/2010, BEING THE TOWN OF PROVOST LAND USE BYLAW.**

WHEREAS the Council of the Town of Provost deems it desirable to amend Bylaw 07/2010, being the Land Use Bylaw, to require development permits to be signed by all registered owners.

NOW THEREFORE, under the authority and subject to the provisions of the Municipal Government Act, S.A. 2000, Chapter M-26.1, and amendments thereto, and by virtue of all other powers it enabling, the Council of the Town of Provost enacts as follows:

1. THAT By-law No. 07/2010, being the Town of Provost Land Use By-law be, and is hereby amended.
2. THAT Section 3.4 Applying for a Development Permit be amended to the following:
 - (1) (c) the owner(s) of the land and the interest of the applicant(s) in the land or the application;
 - (10) An application for a development permit shall be signed by the registered owner(s) or his or her agent(s) where a person(s) other than the owner(s) is authorized to make application. The correctness of the information supplied shall, when required by the Development Authority, be verified by a Statutory Declaration.
3. THAT this By-law shall come into force and effect upon third reading and final passage in Council.



NOTICE

TOWN OF PROVOST

TAKE NOTICE that the Council of the Town of Provost has passed first reading of Bylaw 01/2012 being a bylaw to amend Town of Provost Land Use Bylaw.

The purpose of Bylaw 01/2012 is to amend existing Town of Provost Land Use Bylaw No. 07/2010, to require development permits to be signed by all registered owners.

3.4 APPLYING FOR A DEVELOPMENT PERMIT

- (1) (c) the owner(s) of the land and the interest of the applicant(s) in the land or the application;

- (10) An application for a development permit shall be signed by the registered owner(s) or his or her agent(s) where a person(s) other than the owner(s) is authorized to make application. The correctness of the information supplied shall, when required by the Development Authority, be verified by a Statutory Declaration.

A copy of the Bylaw 01/2012 may be inspected by the public at the Town Office during regular office hours (8:30 a.m. to 4:30 p.m., Monday to Friday).

In accordance with the Municipal Government Act, Provost Town Council during a regularly scheduled council Meeting at 5:00 p.m. on Tuesday, the 17th day of April 2012 will hold a Public Hearing, at which time presentations concerning the proposed bylaw may be made and discussed. Persons claiming to be affected by the proposed amendment or persons wishing to express their views on this amendment may submit oral or written presentations at this Public Hearing.
