
**BEING A BYLAW OF THE COUNCIL OF THE TOWN OF PROVOST TO AMEND
BYLAW NO. 07/2010, BEING THE TOWN OF PROVOST LAND USE BYLAW.**

WHEREAS the Council of the Town of Provost deems it desirable to amend Bylaw 07/2010, being the Land Use Bylaw, to allow for a specific use in the Industrial (M) District, and limiting same to a certain land description.


NOW THEREFORE, under the authority and subject to the provisions of the Municipal Government Act, S.A. 2000, Chapter M-26.1, and amendments thereto, and by virtue of all other powers it enabling, the Council of the Town of Provost enacts as follows:

1. THAT By-law No. 07/2010, being the Town of Provost Land Use By-law be, and is hereby amended.
2. THAT Section 9.13 Industrial (M) District Subsection (3) Discretionary Uses be amended to include the following:
 - t) Residential Dwelling Accommodation Within Building on Lots 1 and 10, Block 7, Plan 0826443.
3. THAT this By-law shall come into force and effect upon third reading and final passage in Council.

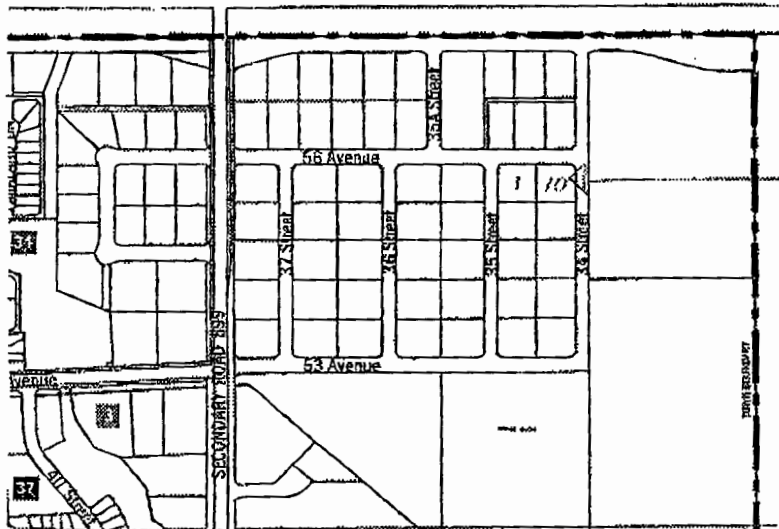
